Patriarchy is a system of social structure and practice in which men dominate, suppress and exploit women (Walby, 1990). In this case, parents as a source to decide for children education is very important related to their experiences in life. Both of them, father and mother have a different one in life. That situation brought them into different ways to make deal with decision. The view related to children, boy and girl based on gender make classified into their class. The culture support that boy can do everything with large chance than girl. But the condition change when parents have another perseption. Social class such as social life build new point of view related to gender perseption toward their children to get education. Bourdieu emphasizes each dimension namely rather and either related to relationally. The old culture that separate between male and female in all element in the specific distric should be delete by the new one. Positive view toward the development of habit as a way in giving the real right to the children. Of course, the special law or qanun that live still maintained. The characteristic as a symbol of one area become the uniquess that must be preserved. Such as education that focus on religion. So it make parents ask their children both of them to take it.

According to Bourdieu (1990) and Wacquant (1992), *habitus* does not act alone. There is an unconscious relationship between *habitus* and field. The relation as meeting of logic and histories or physical and social spaces gives rise to practices. As a simple one, *habitus* related to our ways of acting, feeling, being and thinking. All the choice depend on our need based

on the context. *Habitus* related to past, present, future and also between individual and social. Cause the experiences of someone got from the society develop change life style.

Although father and mother have different past experience in education, but another experiences in life very support to change perception toward something. Father with low education than mother has a view toward education for children. He allow them to take education in different area as a way for children to learn about culture and find another experience as provission for the future. Father's view got from the social interaction entwinted. He knows it from his experiences that learn unconciously.

Bourdieu's concept of field contains important elements of analogies. Social field consisted of position occupied by social agent happens in the field boundaried. Social field does not stand alone. The idea of social field has explanatory. Social agents using differing strategies to maintain or improve the position. Field have its own rules and histories. It is a human set of beliefs which rationalize. Parents with their large social field have their own ways in educated children. Occupation as one of the field build had improve their mind to think about the logic one based on the era. What they saw as references to change the position in the society. Children get good education for better future with the aim to fulfill one of the important position for showing their existence as a part of society.

Bourdieu (1990) state that each social field has distinction or quality. Social field possible to trace the history in specific shape to understand how change happens within a field. Collective people occupy more than one social field. Bourdieu called field of power which is consists of multiple social field namely economic field, education field, political field, etc. Field of power determine an event in each of various social field.

The transformation view of parents by given opportunity for children to take high education aimed for create better generation from the family. Parents will support toward everything have for showing their power through level of children education. The background of change happen cause they have multiple social field such as social economic, past experience through formal and informal.

# Conclusions

Parents perception related to experience brough them into the new one. How another element joint together and build field such as the concept field by Bourdieu. Parents past experiences in education collaborate with economic field and social field change their view to make the same position both of their children, boy and girl in education.
